 - Brett Ridgway (CFO) communicated that we will be putting forth another mill levy override...but this one will actually raise taxes. If you have a \$300,000 home here in this district, your taxes will increase by about \$150 yearly. This will get us halfway to getting our salaries on par with our neighboring districts. He is also working with the state to equalize mill levy funding across the entire state, getting us the other half. The aforementioned local ballot measure is something that Brett will not be able to personally organize or promote, as a 24/7 employee of our district, so he is hoping for community advocates, parents, and teachers (off the clock) to promote it. More information will be coming. Both of these actions would potentially impact '22-'23 funding and salaries.
