Information and Application for 2020-2021

General Information

- The Colorado Exceptional Children's Act (ECEA) and District 49 School Board Policy IHBB, allows highly gifted students, who do not meet the age requirement for enrollment into kindergarten or first grade, to apply for Early Access into school.
- House Bill 1021 stipulates that districts may count in their enrollment and receive State Educational Funds for highly advanced gifted students who meet the criteria established by Colorado.
- The district must abide by the rules promulgated by the State Board of Education.
- The district may charge a reasonable fee for the Early Access process.
- District responsibilities:
 - o Provide early access information to parents
 - o Educate teaching staff and community about Early Access

Definition

Early Access is defined as a highly gifted four-year-old child entering kindergarten, or a five-year-old entering first grade. A highly gifted child is defined as a gifted child whose body of evidence demonstrates a profile of exceptional ability or potential compared to same-age children. A child may be identified as gifted, but still not qualify for Early Access. To meet the needs of highly advanced development, early access to educational services may be considered as a special provision.

Early entrance into school is regarded as a form of acceleration. The decision to accelerate a child can have a profound effect of the child's academic and social performance for the remainder of his/her school career. Therefore, District 49 adheres to a thorough set of research-based procedures to determine if a child is eligible for Early Access.

Application Process:

- 1. Parent/Guardian accesses the Early Access Application packet through the D49 website>Gifted Education>Early Access>Early Access Application or may request a mailed copy by contacting D49 administration building. Early Access into kindergarten requires the student be four years old by the first day of school or five years old by the first day of first grade. The parent/guardian must provide a copy of the birth certificate at the time of the application submission. Information available no later than October 1, 2019.
- 2. The parent/guardian must complete the entire application. The parent/guardian accompanied by the Early Access Candidate/Child, will return the application packet and the student portfolio to District 49 Gifted Education Department on Wednesday, February 26^a, 2020 between 8:00 a.m. 3:30 p.m. <u>OR</u> Thursday, February 27^a, 2020 between 8:00 a.m. 3:30 p.m.
 - Applications will <u>NOT</u> be accepted after Thursday, February 27, 2020 deadline.

- O Per the Military Interstate Compact Agreement, any applications submitted after this deadline are allowed **ONLY** for students who have relocated to District 49 due to parental/guardian military orders. Proof of orders are required and should be included in the application. Determination for Early Access with this agreement will be made no later than School District 49 start date. This is the only exception.
- Child must be present when submitting the application. A question/answer session occurs.
- 3. A complete application must include the following:
 - Initial Application completed and signed (see page 5)
 - Copy of child's birth certificate (child must be 4 the first day of kindergarten, or 5 the first day of first grade)
 - Proof of residence (the child must be living within the District 49 boundaries)
 - A Letter of Request by legal parent(s)/guardian(s) stating why you believe Early Access is appropriate for your child, including any explanations and/or examples that give evidence of your child's highly gifted abilities
 - District 49 Information Release Form (see page 7)
 - Any previous private/public school assessment data if applicable
 - Any other supporting anecdotal information (letters of recommendation from teachers, coaches, or mentors; report cards or evaluations; examples of observable behaviors)
 - Student portfolio of work
- 4. A student portfolio of work must include artifacts that the child has completed within the past year. Each document should be dated. The portfolio should include but is not limited to the following examples of student work:
 - Knowledge of number sense
 - Knowledge of beginning alphabet sounds
 - Knowledge of shapes
 - Knowledge of colors
 - Examples of writing
 - Evidence of reading ability
 - Evidence of student interests
 - Samples of student drawings/artwork
 - Any other items the parent deeps appropriate
- 5. Upon submission of completed application and student portfolio, the child will be administered a brief screener determining if child will move forward in the Early Access process. If a child is determined to be an appropriate candidate to move forward, then a team of educators knowledgeable of gifted education and early childhood development will evaluate the application and portfolio utilizing the Early Access rubric (see page 6). If it is deemed the child is not a candidate for additional testing, the parent/guardian will be notified of the team's decision.

- 6. The following procedure will be followed if the student moves to the next level of the Early Access process:
 - A license/trained professional will administer the Test of Early Mathematic Ability (TEMA), the Test of Early Reading Ability (TERA) and/or the Test of Early Written Language (TEWL) on **March 5, 2020** with appointments beginning at 8:00 a.m.
 - Parent/Guardian will be notified immediately if child scored the minimum of 97th percentile on given assessment. <u>ALL three assessments: TEMA, TERA, and TEWL</u> scores have to be at or above the 97th percentile. *If one assessment does not meet the minimum, testing will not continue and the process will conclude indicating child does not qualify.*
 - Early Access Team will collaboratively determine if the child is an appropriate candidate for final level for Early Access into kindergarten or first grade.
- 7. The final level of Early Access Process:
 - District 49 school psychologist will administer the Wechsler Preschool and Primary Scale of Intelligence (WPPSI) between **March 6 March 27, 2020**. Candidate must score a minimum of the 97^a percentile to advance in the process.
 - Parent/Guardian will be notified of committee's decision based on data from entire process within one week of administration of WPPSI.

Early Access Team Members

Members of the Early Access team will consist of the following professionals:

- D49 Gifted Education Coordinator
- D49 Gifted Education resource specialist
- Primary School Teacher
- Psychologist
- Other members as deemed appropriate

Dispute of Findings

Parent/Guardian disputes may be made in writing stating reasons for dispute within five days of the most recent step completed in Early Access Process.

- Meeting between D49 Gifted Education Coordinator and parents/guardians to review data is scheduled.
 Resolution achieved.
- If no resolution, meeting between Executive Director of Individualized Education and parent/guardians is scheduled. Resolution achieved.

Non-acceptance:

No further application for Early Access will be considered at any other school or institution within the school district. Student files are transferred to the receiving school within District 49 for instructional programming for the appropriate year and grade. All testing materials and results become the property of District 49.

Early Access Criteria Established by Colorado Exceptional Child Education Act:

Criteria established by Colorado and District 49 for the early identification of a highly gifted child include:

- Score of 3 or 4 on every portfolio submission utilizing the performance rubric
- Portfolio review and/or student observation demonstrated appropriate developmental social-emotional and motivational behaviors
- Reading achievement, writing achievement, math achievement and intellectual scores of 97th or above
